Letter of Information

The purpose of this letter is to request your understanding and co-operation in maintaining your health and safety, and also in protecting London Canoe Club (herein called LCC) equipment and property.

You should be aware of the risks associated with canoeing and tripping. The degree of risk is dependent on a blend of your health, your canoeing skills, the adequacy of the equipment you use, the weather and the water conditions. Safe practices begin with acquiring skills in canoeing or kayaking and with wearing a personal flotation device while on or near the water.

Lessons are available several times throughout the season. Personal flotation devices should be worn while on the water. Assess your strength and skills before choosing the activity. Seek assistance in moving canoes to and from the boathouse if needed.

Participation in all LCC activities is voluntary, and therefore the individuals participating assume all risks and liabilities.
